



'A Call to Repentance to the So-Called Apostate Somali Tribal Elders'

12 Dulqicdah 1440 H (15/07/2019)

Allaah, The Exalted, said in the Noble Qur'an:

"Have you seen those (hypocrites) who claim that they believe in that which has been sent down to you, and that which was sent down before you, and they wish to go for judgement to the Taghoot (false judges, etc.) while they have been ordered to disbelieve in them. But Satan wishes to lead them far astray.

And when it is said to them: "Come to what Allaah has sent down and to the Messenger," you see the hypocrites turn away from you with aversion.

How then, when a catastrophe befalls them because of what their hands have sent forth, they come to you swearing by Allah, "We meant no more than goodwill and conciliation!"

They (hypocrites) are those of whom Allaah knows what is in their hearts; so turn away from them (do not punish them) but admonish them, and speak to them an effective word that reaches their inner selves.

We sent no Messenger, but to be obeyed by Allaah's Leave. If they (hypocrites), when they had been unjust to themselves, had come to you and begged Allaah's Forgiveness, and the Messenger had begged forgiveness for them: indeed, they would have found Allaah All-Forgiving (One Who accepts repentance), Most Merciful.

But no, by your Lord, they can have no Faith, until they make you (O Muhammad) judge in all disputes between them, and find in themselves no resistance against your decisions, and accept (them) with full submission." [Nisaa, 60-65]

In the aforementioned verses, Allaah, instructs the believers to submit fully to the law and judgment of Allaah and His Messenger (peace be upon him). He, the Exalted, commands the believers not to go to the disbelievers for judgment and to reject all legislations that are contrary to the Law of Allaah.

The only form of legislation that Allaah has chosen for mankind and that can unite the Muslims all over the world is Islamic Shari'ah. Any other form of legislation besides the law of Allaah is considered null and void and worthy of being abolished.

Allaah, The Exalted, said:

"Do they then seek the judgement of (the Days of) Ignorance? And who is better in judgement than Allah for a people who have firm Faith." [Mai'dah, 50]

"You do not worship besides Him but only names which you have named (forged), you and your fathers, for which Allah has sent down no authority. The command (or the judgement) is for none but Allah. He has commanded that you worship none but Him, that is the (true) straight religion, but most men know not." [Yusuf, 40]

Since the right of legislation solely belongs to Allaah, the leadership of Harakat Al-Shabaab Al Mujahideen hereby notifies all Muslims that the so-called tribal elders who appointed the members of the apostate Somali Parliament have fallen into clear-cut disbelief that has invalidated their Islam, nullified their faith and led them towards the path of apostasy and misguidance.

The so-called apostate tribal elders are the ones who selected the apostate parliamentarians who are contending against Allaah in His sole right to legislate and govern, and have openly declared themselves as the lawmakers of the people and country. These tribal leaders are the ones who have facilitated and laid down the foundation for:

- Somalia to be governed by other than the legislation of Allaah
- The apostate lawmakers to be idolized and obeyed as gods
- The Somali people be ruled by constitutions of disbelief
- The sinister agendas of the crusaders to be implemented upon the Muslims
- The land of the Muslims to be subjected to occupation and its resources plundered by Ethiopia and Kenya, etc
- The disbelievers to find safe havens and assistance in their crusade against the Muslims
- The rule of Islamic Shari'ah to be abolished in Somalia
- The immorality and decadence to be spread in the chaste Muslim society

As such, the leadership of Harakat Al-Shabaab Al Mujahideen hereby issues a call to repentance to the so-called tribal elders who participated in the selection of the apostate parliamentarians demanding that they repent to Allaah, disavow themselves from the disbelievers and accept the sovereignty of Allaah's Law above all forms of legislation.

The Mujahideen's leadership will give the so-called tribal elders a respite of 45 days starting from 15/07 / 2019 until 01/ 09 / 2019 to openly declare their disavowal and repentance and register their names with the Islamic Wilaayaat in order to safeguard their lives.

Allaah, the Exalted said:

"Except for those who repent before they fall into your power; in that case, know that Allaah is Oft-Forgiving, Most Merciful." [Mai'dah, 34]

If they repent to Allaah and return to the Truth, then they will be accorded all the due respect, esteem and brotherhood obligated by Islam. If they persist upon their path of misguidance, however, and do not repent from their disbelief within the specified period, the Mujahideen pledge to execute the command of Allah fully without hesitation.

The so-called apostate tribal elders should know that they will never relish in safety and stability in Somalia as long as they are in a state of clear disbelief. They will not find a safe haven or protection against the Mujahideen.

Finally, Harakat Al-Shabaab Al Mujahideen's leadership also strongly cautions all the tribal elders in Somalia against taking part in the establishment of apostate administrations and cooperating with the crusaders and their allies in their war against Islamic Shari'ah and the Muslims in Somalia.
